International regulation aspect

The invoicing process is regulated by fiscal and commercial laws. Those laws could differ depending on the invoice format, the country and the economic region. In Europe, member states has already transposed the 2010/45/UE directive since January, 1st 2013.

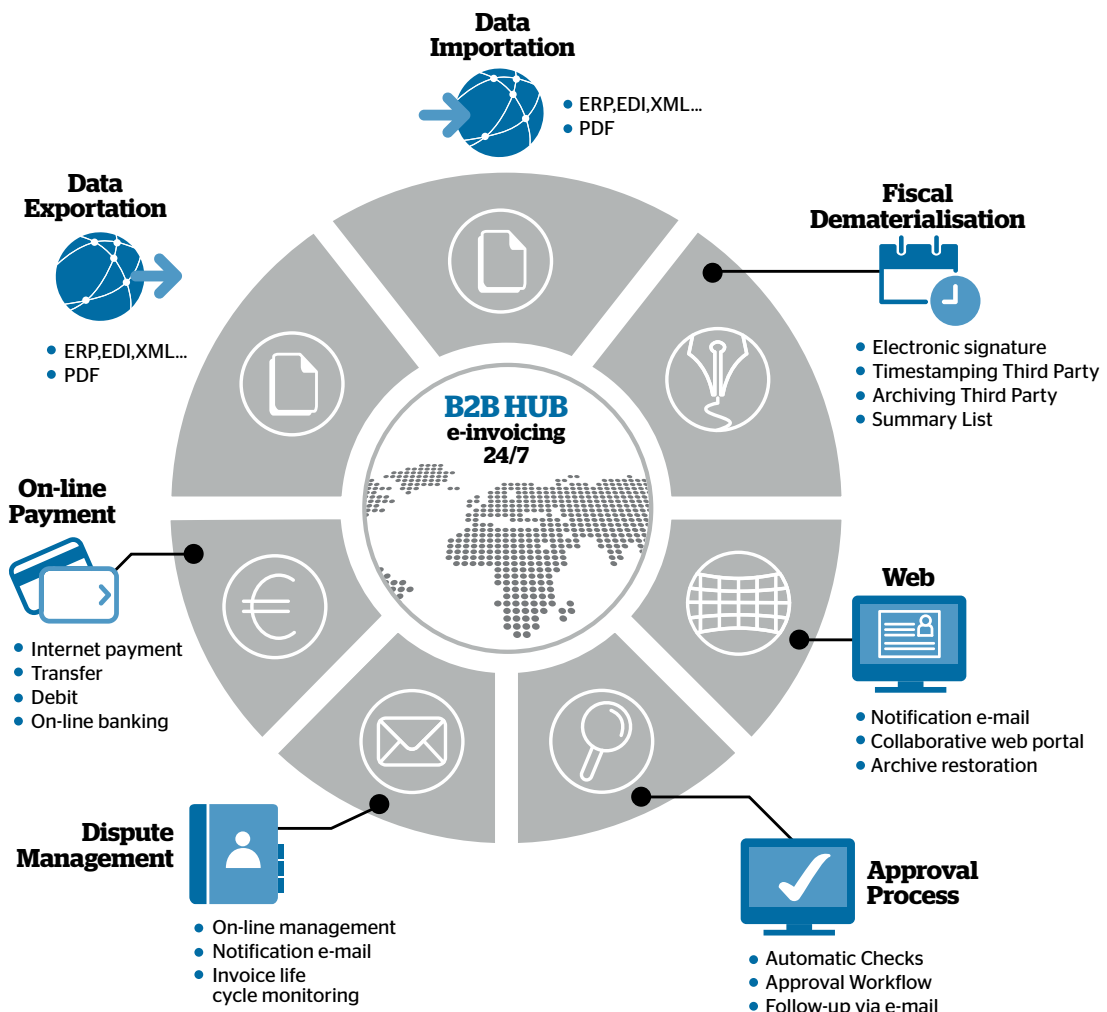
